What is CIF Catalog?





What is CIF Catalog?

 A static catalog (CIF) is a text file stored on Ariba Network that describes the products and services your organization offers and the prices you charge. Your buyers's users access your catalog through SAP Ariba Procurement to purchase your products and services offerings.






CIF Catalog Enablement Process

Buyer's Prerequisites to Start:

- Catalog Requirements Completed
- Catalog Approvers Identified
- Commodity Codes & UoM Loaded
- Supplier Master Data Enriched (Supplier ANID added)
- Escalation Path Defined
- Catalog Content Clarified with Supplier

Supplier's Prerequisites to Start:

- Catalog Content Clarified with Buyer
- Ariba Network Trading Relationship Established
- Ariba Network Test Account Created
 - Important: All Steps are explained in the Supplier Account Registration Guide provided by SGRE



Buyer Testing might be extended up to 8 weeks if transaction integration is requested by the Supplier

Publishing a Catalog on Ariba Network





Catalog Publication on Ariba Network

- Your static catalog will be uploaded by your CUSTOMER first to TEST on Ariba Network.
- Once the catalog has been published and validated in TEST, your catalog will be reuploaded and activated in Ariba Network PRODUCTION.
- Should you have questions as to the process, please respond directly to the SGRE email that has requested a catalog from you for further alignment with your CUSTOMER.

Catalog Update on Ariba Network

- Any updates of your catalog content have to be alignment with your customer.
- For any catalog update, please provide a newly filled out CIF template. Best practice: use the last CIF template that has been confirmed by the customer, and change only the required elements. Re-send the template to the customer with request for update upload.
