

Dear Valued Costco Wholesale Supplier,

This letter is to inform you of our 30-day cutover period until our Go-Live with your company on the Ariba Network on **Monday, September 30<sup>th</sup>, 2019**. Please note, adoption of the Ariba Network is mandatory for suppliers wanting to do business with Costco Wholesale.

If you have any outstanding onboarding tasks or would like to update your **Ariba Network Settings**, please make sure these are completed in the coming weeks. #### **What “Go-live” Means to You**

- All purchase orders will be routed electronically via Ariba Network
- Invoices will no longer be accepted by fax, postal mail, or e-mail
- All invoices must be sent using Ariba Network

#### **How to Prepare for Go-live**

- Respond to all requests from Costco Wholesale and Ariba in a timely manner
- Ensure that your Ariba Network account is configured to your organization’s specifications
- Plan to register and attend Ariba Network functional training for Costco Wholesale suppliers (see registration links below)

#### **Are You an Integration Supplier?**

- Do you transact in cXML or EDI?
- Do you have resources to support PO-Flip invoicing?
- Have you integrated on the Ariba Network in the past?

#### **Costco Wholesale Supplier Ariba Network Function Training**
