Glossary

Depository Institution Name

An organization, which may be either for-profit or non-profit, that takes money from clients and places it in any of a variety of investment vehicles for the benefit of both the client and the organization. Common examples of depository institutions are retail banks and savings and loan associations, both of which take deposits into safekeeping and use them to make loans to other customers.

Bank Country

Identifies the country in which the bank is located.

Bank Key / Routing Number / Sort Key

In this field, you specify the bank key under which bank data from the respective country is stored. When you define the country key, you also specify the country-specific definition of the bank key. Normally, you manage banks using their bank number. The bank number in the control data for the bank is then displayed twice, that is, as the bank key too. In certain countries, the bank account number takes on this function; then there are no bank numbers and the bank data is managed using the account number. For data medium exchange, you may find it useful to be able to enter foreign business partners without a bank number, even if there are bank numbers in the country in question. In this case, the bank key can be assigned internally. To manage bank data using another key, for example, the SWIFT code, external number assignment can also be used.

Bank Control Account Key

This field contains a key for checking the combination of bank number and bank account number.

Branch

This field contains the branch name of the financial institution.

Bank Account Holder Name

Here you can enter another name that the payment program can use if the name of the account holder is not the same as the name of the customer or vendor.

Bank Account Name

This field contains the number under which the account is managed at the bank.

Bank Type (Currency)

Key you enter in the line item to specify which business partner's bank the system should use.

Bank IBAN Code

A standard international numbering system developed to identify an overseas bank account.

Swift Code

SWIFT stands for Society for Worldwide Interbank Financial Telecommunication.
