#### **Customer challenge**

Prior to this feature, buyers would be required to add requisition line items and details manually requiring a significant number of additional effort to perform purchasing on mobile.

This feature enables SAP Ariba Procurement mobile app users to create new purchase requisitions by making copies of existing purchase requisitions and add new line items in purchase requisitions by making copies of existing line items.

#### **Prerequisites**


- You must have downloaded the SAP Ariba Procurement mobile app to your mobile device and have the required sign-in information.
- You must belong to the Ariba Mobile User group in order to use the SAP Ariba Procurement mobile app.
- You must have updated the app to the latest version.
- You must belong to the Mobile Shopping group in order to use the shopping cart feature, unless the site is configured to bypass the group membership check for the Mobile Shopping group.
- Ensure that you have enabled the Enable copying of purchase requisitions and requisition line items in the SAP Ariba Procurement mobile app (Application.Mobile.EnableCopyPRAndLineItem) site configuration parameter to enable this feature.

## **Copying Requisitions**


- Users can use the **Buy again** menu option to make a copy of an existing requisition.
- Users can then modify requisition details, add or delete items, and submit it for approval.
- Requisitions can be copied regardless of their state
