Enabling History Records for Enriching Requisition Data in External Systems (CP-21901)

Enabling history records for enriching requisition data in external systems

Description

- For sites that are configured for external validation and enrichment of approvable data, this feature enables history records for changes made to requisitions by external systems while enriching the requisition data.
- SAP Ariba Procurement solutions allow the export of some requisition data to an external system for processing, including validating the data and enriching it if needed. The enriched data received from the external system is automatically updated in the corresponding fields in the requisition.

Customer benefit

- Previously, there was no indication shown to users that the data has been enriched. Now, when this feature is enabled, users can view these changes in the history records.

Prerequisites, restrictions, cautions

Prerequisites

- Your site must be configured for external validation and enrichment of approvable data.
- The `Application.Purchasing.AllowRequisitionEnrichment` (SAP Ariba Support enabled) parameter must be enabled.
- Your administrator must configure the **Process Requisition Externally** web service integration task, to send the requisition data to external systems to be validated and enriched.
- Your administrator must enable the **Enable history records for enriching requisition data in external systems** (`Application.Procure.ValidateEnrich.Requisition.EnableHistoryRecordsForEnrichment`) parameter.

Cautions

- When you click the Check button while composing a requisition, the data is sent to the external system for validation and enrichment. Then, the enriched data received from the external system is updated in the corresponding fields and a history record is created for the changes. Any further changes that you make to the enriched data while the requisition is in the composed state are not captured in the history.
