Feature Description

This feature prompts both existing and new Chilean enterprise suppliers to select the applicable economic activity code (GIRO).

The selected economic activity code is displayed in the transaction fee invoice of Chilean suppliers.

What is economic activity code?

Code related to an activity that involves the production, distribution, and consumption of goods and services. This field is required for Chilean suppliers. User Interface Changes

1. When an account administrator or user with Marketing Profile privilege logs into SAP Business Network, a screen appears with the list of economic activity codes and descriptions.
2. Suppliers can use the drag down option or use the search filter to select the applicable economic activity code.
3. You can also view and change the selected economic activity code at a later stage.
 - Click the Account Settings icon on the top-right corner of the page and select Marketing Profile.
 - Click the pencil icon next to the GIRO section. The list of economic activity codes and descriptions appears on your screen.
 - Select the applicable economic activity code and click Save.
