Attachments in the events are not accessible to buyers during bidding to protect bidders' identities. Prepopulate region, category, and department values from request or registration to process qualification [SM-30932]	This feature introduces an enhancement that prepopulates commodity, region, and department values in intake forms with entries from supplier request or registration. If a supplier has both a request and a registration with this data, the registration data is used to prepopulate the intake form. Therefore, you no longer have to manually select these values in intake forms while creating process qualifications for your suppliers. However, if you are creating a process qualification for a different matrix combination, you must use the dropdown menu to select the desired matrix values. Commodity, region, and department values in intake forms are prepopulated based on the following inbuilt rules: •If both supplier request and supplier registration contain identical or different matrix values, the intake form is prepopulated with data from supplier registration. Note: If matrix values from supplier registration are available, they always override values from supplier request. For example, if supplier request contains commodity, region, and department values, all the matrix values of supplier request. •If a supplier request contains matrix values and supplier registration does not, the intake form is prepopulated with data from the supplier request. •If both supplier request and supplier registration do not contain any matrix values, the intake form is prepopulated with data from the supplier request. # Ability to Block Classic Sourcing Creation and Switch to the New Guided Sourcing Interface [SS-37006]

## Enhancements to the guided sourcing event award process

### Description

 This feature provides the ability to block users from creating sourcing projects and sourcing requests in the SAP Ariba Sourcing\* interface and encourages users to switch to and experience guided sourcing, the new user experience of SAP Ariba Sourcing.

#### **Customer benefit**

- Foster adoption of guided sourcing:
- The user will no longer be able to create a project in the SAP Ariba Sourcing user interface and all existing projects in SAP Ariba Sourcing will be redirected to guided sourcing
- In addition to this feature, an end user who is currently working in SAP Ariba Sourcing, can get informed about guided sourcing, the new user experience for SAP Ariba Sourcing.

## Prerequisites

- This feature is supported only in the classic SAP Ariba Sourcing user interface.
- <u>Guided sourcing enabled</u> must be enabled in your realm and you must be a member of the Category Buyer group.
- For new customers:
- the parameter Block classic sourcing creation
   (Application.AQS.RFX.BlockClassicSourcingCreation) is enabled by default during site
   deployment to make sure that new customers use only guided sourcing for project creation.
- For existing customers:
- if you want to block project creation in SAP Ariba Sourcing and use guided sourcing instead, you need to submit a service request to SAP Ariba Support to enable this parameter.
- To open full sourcing projects and sourcing requests which were created in SAP Ariba Sourcing in guided sourcing, the ICM parameter Open classic sourcing projects and sourcing requests in guided sourcing (Application.AQS.RFX.NavigateToNewUIExtension) must be set to Yes
  - As the quick project structure in Guided Sourcing is different from the quick project structure in SAP Ariba Sourcing, the quick project created in the SAP Ariba Sourcing interface will continue to open in SAP Ariba Sourcing, independent of the parameter value

- To switch from SAP Ariba Sourcing to guided sourcing through sliders and popup messages displayed in SAP Ariba Sourcing projects, the ICM parameter Show options to switch to guided sourcing (Application.AQS.RFX.ShowOptionsToSwitchToGuide dSourcing) must be set to Yes.
  - This parameter does not require customers to have guided sourcing enabled or be in the Category Buyer group. However, customers are advised to enable guided sourcing and be a member of the Category Buyer group to have a full experience of guided sourcing.

## Restrictions

- If the ICM parameter Open classic sourcing projects and sourcing requests in guided sourcing (Application.AQS.RFX.NavigateToNewUIExtension) is set to Yes, full sourcing projects and requests created in SAP Ariba Sourcing are all opened through the guided sourcing interface, whereas quick sourcing projects are still opened through the SAP Ariba Sourcing interface.
- Customers have the advanced option Create My Test Project in a sourcing template to create test projects from a template. For guided sourcing templates, the Create My Test Project option always opens the guided sourcing interface.
- For sourcing templates in SAP Ariba Sourcing, if the parameter Block classic sourcing creation (Application.AQS.RFX.BlockClassicSourcingCreation) is set to Yes, the Create My Test
   Project option opens the Guided Sourcing interface for full test projects/Sourcing request. For quick project the interface remains dependent by the property "Is Guided Sourcing = Yes"
- If this parameter is set to No, the Create My Test Project option in SAP Ariba Sourcing templates always opens the SAP Ariba Sourcing interface.

## User interface changes

Three parameters are available to control the UI for sourcing project/request creation:

1. Block classic sourcing and only allow Guided Sourcing Project and Request creation (enabled by default for new deployments at release)

- 2. Open classic sourcing projects/request in guided sourcing
- 3. Show a slider and a pop up message during project/request creation

If parameter #1 to block project/request creation in the SAP Ariba Sourcing interface is set to Yes (by SAP Ariba Support), the following user interface changes are applied:

 The Sourcing Project and Sourcing Request options are hidden from the Create and Common Actions menus on the SAP Ariba Sourcing dashboard and any action to create Sourcing Project in the application (e.g. create a subproject from a Contract workspace) will be redirect to the guided sourcing interface.



## Cumulative aggregation of ratings in internal forms or questionnaires

### Description

- This feature enables internal stakeholders of your organization to enter ratings in one or more internal forms or internal questionnaires of a project.
- You use Ratings to evaluate or "rate" the responses (on various parameters such as delivery, quality, service, price, compliance, and so on).
- You also configure a new answer type called **Total Rating** in an internal form or internal questionnaire of the project. This non-editable field is automatically aggregated and populated in internal questionnaires or forms where it is configured.

#### **Customer benefit**

- Ratings enable your organization to create a formal methodology by which you evaluate responses.
- Approval decisions can be taken based on the aggregated scores from multiple internal form scores.

## Prerequisites, restrictions, cautions

#### Prerequisites

- For SAP Ariba Supplier Information and Performance Management, this feature requires the "new architecture."
- The feature that offers support for workflows with internal forms in modular questionnaire projects (SM-30222) must be enabled in your site.
- To create and edit modular questionnaire project templates, you must be a member of both the Template Creator and SM Modular Questionnaire Manager groups.
- To enable workflows with internal forms and To Do tasks in a modular questionnaire project template, on the **Overview** tab of the template, set the **Allow multiple internal forms** property to **Yes**.
- To edit an internal form in a modular questionnaire project, you must be either the project owner or the owner of an
  active To Do task on that form.

#### Restrictions

- If both Rating and Total Rating are configured in the same form, the Total Rating value is not updated dynamically when the form is being edited. In such cases, users can see the updated total rating only in View mode after submitting the form.
- This feature is not supported in internal repeatable sections.
- The questionnaire project details page does not include SAP Companion in-app help.

## **Feature details**

"Rating" answer type enables you to create a formal methodology by which you can evaluate your respondents' answers. You may add multiple ratings questions as appropriate to your needs. Special properties of Ratings answer types include:

- 1. Rating Type (defaults to "Numeric")
- 2. Max Rating (1 to 100)
- 3. Rating Weight (1% to 100%)

"Total Rating" answer type displays an aggregate of ratings of all the internal forms in a questionnaire project. Although you can configure this field in any internal form of a questionnaire project, we recommend that you configure this field only in the "final" form. The "final" form is the one in which an approver of a questionnaire project chooses to approve or deny the project. Total Ratings answer type has one special property:

# Ability to Access Process Creation Status When a Process is Created for One or More Suppliers at a Time [SM-35129]

# Ability to access process creation status when a process is created for one or more suppliers at a time

### Description

- Customers can create qualification and miscellaneous processes for one or more suppliers at a time (SM-21456).
- This new feature provides enhanced status information on whether a process created by customers for one or more suppliers has succeeded, failed, or is in some other status.
- After customers have sent a process to one or more of their suppliers, customers can obtain the status through various methods:
  - User Interface
  - API endpoint
- Email

Customers are now able to obtain process status across processes, suppliers, and questionnaires via multiple methods, giving customers better insight and quicker access to manage their supplier data collection efforts.


#### Prerequisites

- The process project feature (SM-16798: New Modular Process Framework for Qualification and Custom Supplier Lifecycle Processes) must be enabled and configured in your site.
- You must be a member of the **Template Creator** or **Customer Administrator** group to edit email templates.
- API client applications cannot request an update for a questionnaire during process project creation if the questionnaire is in **Pending Submission** or **Pending Approval** status.

## **Feature details**

A new Processes page displays a list of all the processes that are sent to one or more suppliers. This page also displays the corresponding job statuses. To navigate to this page, go to Manage > SM Process Flow.

- 1. Details include Process Type, Category, Supplier Count, Matrix Values, Process Owner, and Creation Date.
- Supplier Count lists the number of suppliers the process creation was initiated for. Clicking the hyperlinked count value displays the process creation status for each invited supplier.
- 3. Clicking the view icon (2) opens the specific process detail page for a supplier.

## **Feature details**

A new email template is added at Manage > Administration > Project Manager > Project Email Templates > Project Type: SM Process Project. The user that initiated the process automatically receives an email after the background job is completed. Customer administrators can optionally personalize this new email template.

#### Restrictions

The CreateModularQuestionnairesFromStandardAssessments scheduled task creates a modular questionnaire template named **Human Rights**, mapped to the SAP Business Network standard assessment of the same name. It does not currently have the ability to create modular questionnaire templates for any other SAP standard assessments.



#### **Feature Overview**

- The Human Rights modular questionnaire template is mapped to an assessment of the same name on SAP Business Network, and specific questions on the two sides are mapped to each other.
- With this feature enabled, you can set up a modular questionnaire template to have responses for an engagement risk assessment imported from SAP Business Network.
- Once setup is complete, the send assessments task does not send the assessments configured to import responses to the supplier; instead, responses for those assessments are imported.
- The response import can happen only when the SAP Business Network registered supplier has responded to the assessment on the SAP Business Network side, and has approved sharing that response.
