Legal context

Logistic Providers (LP) must send Brazilian Legal Freight Invoice, better known as CTe (Conhecimento de Transporte), to document the supply of transport services.

SBN/Ariba Network supports CTe 3.00 today.

SEFAZ (Brazilian Tax Authority) has released the Manual of CT-e 4.00 Version going to production In June 2023.

Feature availability

Please note we are announcing this feature with the 2311 release to raise awareness of this change. All customers will be able to use the feature as of Dec 4th to meet the Jan 31st compliance deadline.

The current CT-e 3.00a version can be used in parallel with version 4.00 until 31st of January of 2024 – therefore this is the final deadline for customers to migrate to version 4.00.

Fiscal validations through Brazilian Tax Authority services

- All incoming CTe invoices are validated through Brazilian Tax Authority (aka SEFAZ) web services enabled for CTe version 4.00
- SEFAZ Services are called based on the corresponding Brazilian state related to the CTe document
- If the main service is down, an alternate service is called.
- If a document does not pass that validation, it is then failed by the system with the error code and description received from SEFAZ. Otherwise, it continues the flow in the Network.
