Feature Description

This new functionality on Network Catalog solution enables suppliers to easily maintain carbon footprint data for their products on Network Catalog.

The existing product details template has been modified to add additional attributes related to carbon emission and circular economy. The added carbon emission fields are compliant with Partnership for Carbon Transparency (PACT) framework.

All these fields are optional fields in the product detail template. Suppliers can showcase their efforts towards sustainability and to be carbon transparent by providing this information to the buyers.

Key Benefits

- Enable buyers to use the carbon emission information provided by the suppliers to make an informed decision which aligns with their sustainability strategy.
- Suppliers can distinguish themselves and their products from other suppliers by providing product carbon emission data.

 All Buyers who have access to network catalog solution can view the carbon emission details for the products for which suppliers have provided the carbon emission details.


Restrictions


Network Catalog functionality is only available for enterprise account suppliers. Suppliers with standard account must consider to upgrade to benefit from the Network Catalog functionality.

Data Centre considerations: The solution uses US data centre but can support global users


Supplier Product Manager Task – Download Product Detail Template with Sustainability fields

- Please read the template instructions on how to fill the sustainability information.






Supplier Product Manager Task – Edit sustainability details for the product using UI
