Description

- Buyer administrators can now enable SAP Ariba Procurement mobile app users to create requisitions using BMEcat and Excel catalog items where the price and quantity are configured by the catalog administrators.
- In addition where mandatory items have been configured these are also added when a user adds the item.


Restrictions


SAP Ariba Procurement mobile app doesn't support the following for BMEcat or Excel catalog items:

- Related items such as similar items, optional accessories, spare parts, and follow-up items
- Related documents such as product information sheets or user manuals
- Auxiliary images and thumbnails

Feature details

- Buyer administrators can now enable SAP Ariba Procurement mobile app users to create requisitions with BMEcat and Excel catalog items whose price and quantity are configured by the catalog administrators. Additionally, mandatory items are also added when a user adds the item.
- For a BMEcat item, pricing and quantity details are also displayed on the item details page. Mandatory items, if any, are also displayed.
