## Feature Overview

# Introducing: Enhancements to SAP Business Network Trading Partner Registration NS-28269

## Feature Description

This feature brings possibility to require additional validation at consolidation for SLP and Sourcing registration flows for customers in Brazil

- If Brazilian supplier chooses to use existing account, SBN will validate if the TAX ID passed by the customer in registration form matches the TAX ID associated with the account chosen for consolidation
- In case supplier chooses to create a new account, TAX ID field is locked for consolidation.
- If Supplier from a country other than Brazil chooses to use existing account SBN will validate if the country passed in the registration request matches the country in the supplier company profile.

## Key Benefits

This enhancement minimizes the risk of incorrect consolidation for the suppliers that have several accounts

In Brazil it's common practice to outsource event response to 3<sup>rd</sup> party service providers where the same agents have access to several ANIDs
