## Support for AI-Generated Product Summary and Description for Network Catalog Products – [BNCAT-2497]

### Description

This feature enables suppliers to generate the product summary and description of a network catalog product using AI. The existing product information such as product name, product description, product summary, manufacturer name, and product category as per UNSPSC category code will be used to generate the product summary and product description. In addition to the existing product information, suppliers can also add more details as prompts to generate AI-enhanced product summary and description. It enables suppliers to better organise the content and improve readability.

# Support for Bulk Actions on Staged Network Catalog Products – [BNCAT-2498]

## Description

Suppliers can perform bulk actions on the staged network catalog products, such as publishing products, sending products for approval, and approving products. The specific actions available depend on the supplier's role and the status of the products.

1. Publish all Products: Suppliers with both the product approver and product manager roles or an administrator role can publish the products with the complete status and matching the page filter criteria, to the online version.

2. Send all Products for Approval: Suppliers with the product manager or an administrator role can send products only with the complete or rejected status and matching the page filter criteria for approval.

3. Approve all Products: Suppliers with the product approver or an administrator role can approve the products with the pending approval status and matching the page filter criteria.

# Improve Supplier Visibility of Purchase Order Line Items Deleted by Buyers – [CSC-34486]

### Description

This feature improves visibility for suppliers when buyers delete line items in regular purchase orders. When buyers delete line items, SAP Business Network prevents suppliers from submitting documents (order confirmations, ship notices, invoices, service entry sheets, and others) against these line items. Prior to this feature, SAP Business Network prevented suppliers from submitting documents against deleted line items, but suppliers did not have sufficient visibility about which line items were deleted.

# Enhancement for Japanese Invoices to Display Tax Rate of Line Items – [NG-6369]

Description

With the introduction of TEKIKAKU SEIKYUSHO TOU HOZON HOUSHIKI invoicing method in Japan, SAP Ariba Buying and Invoicing displays the tax summarization calculated at the header level during invoice creation.

You can now display the tax rates for each line item on SAP Ariba Buying and Invoicing for Japanese invoices. This is possible by creating custom fields that can capture the tax rates of the line items and additional line-item information, if available.

## **Customer Benefit**

Our customers have identified an issue with the current implementation of NG-6139, wherein on the B&I application, customers are struggling to determine the applicable tax rate at the line level on the UI. This challenge is causing difficulties related to invoice approval. While invoice reconciliation is where the information exists, sometimes it is not easy to validate, and a few parameters also need to be enabled to get the tax line level view, This is not an efficient or effective solution for all customers, particularly those who do not utilize invoice reconciliation. Furthermore, to comply with the six requirements of a qualified invoice in Japan, determining whether each line item belongs to a reduced or standard tax rate (the third requirement) is currently a cumbersome process in B&I. While this process is manageable in SAP Business Network, the same cannot be said for B&I. Additionally, for external tax engines that use the SAP Ariba API for data extraction, this information is currently unattainable.
