You can use the new API to connect to D&B Direct+ if your company has the relevant licensing with Dun & Bradstreet. This would replace the need to integrate with D&B Worldbase Marketing Plus.

Are you aware of any change in license with D&B as a result of moving to D&B Direct+?

You must have a license for D&B Direct+, the product must be activated, and you must have a consumer key and secret for it.

Answer

Supplier performance from SPM projects are not planned to be incorporated into the new supplier 360. This is because we at SAP are currently working on a new, improved method to measure suppliers on an ongoing basis including their ongoing performance called supplier evaluation. Supplier evaluation will greatly improve the efficiency, visibility and flexibility of measuring supplier performance and is planned for release in 2411.
