# Ability to Add Network Catalog Products Without Setting a Price – [BNCAT-2200]

#### Description

Having valid prices listed in your network catalog increases the chance of potential buyers contacting you or making a purchase. However, it can sometimes be challenging to determine a public price for complex or configurable products. SAP Business Network now allows you to add products to your network catalog without having to define a public price. Buyers can inquire about the price by sending you a check price request.

#### **Customer Benefit**

1. Flexibility: Allowing suppliers to upload catalogs without prices gives them the flexibility to update and modify their product offerings without having to constantly update prices.

2. Reduced complexity: Managing and updating prices for a large number of products can be complex and time-consuming. Allowing suppliers to upload catalogs without prices simplifies the process by separating the product information from the pricing information. This can make it easier to manage and update product catalogs, reducing the risk of errors or inconsistencies in pricing data.

## Description

Subcontracting processes are quite diverse based on industry and customer requirements. There is the need to track and validate the lifecycle of finished products and contained components.

Component consumption in subcontracting scenario includes both validations and Usability enhancements.

# Business Rule transport from test to production system – [CSC-42902]

Description

Export of business rules (Default transaction rules and supplier group rules) from one Buyer account and import in another buyer account.

## Freight Collaboration between SAP Business Network Supply Chain Collaboration and SAP Business Network for Logistics – [CSC-47279]

Description

Support for Buyer managed transportation scenario where the Buyer completely outsources the shipment planning and execution to the Logistics Service Provider. The LSP handles shipment planning and manages its execution via contracted carriers. This covers the transportation planning without capacity pre-booking.

# Support for PDF with Embedded UBL Invoice for KSA – [NG-6119]

Description

Buyers can now receive PDFs containing embedded UBL invoice from suppliers of the Kingdom of Saudi Arabia through email. This feature is applicable only for PDFs generated outside SAP Business Network (inbound flow). The embedded UBL invoice in the PDF is the legal invoice approved by the Saudi Arabian Tax and Customs Authority (ZATCA).

**Customer Benefit** 

This feature will enable suppliers in Saudia Arabia to e-mail PDF invoices which have the mandated UBL xml embedded.

# E-Invoicing in Romania for Outbound Invoices-[NG-6482]

#### Description

The Romanian tax authority known as National Agency for Fiscal Administration of Romania (ANAF), mandates the Romanian suppliers to issue electronic invoices for domestic and cross-border transactions, effective July 2024. To adhere this mandate, SAP Business Network now supports electronic tax invoicing in Romania for outbound invoices (invoices created by suppliers using SAP Business Network). This functionality allows invoices generated on SAP Business Network validate against the ANAF portal and receive the Romanian UBL invoice as an attachment. As a result, buyers will be able to receive invoices according to the new mandate.

Enable the AN outbound feature to be extended to Romanian customers.
