# Introducing: New harmonized Terms Of Use (TOU) for Network Suppliers participating in Spot Buy program

## **Customer challenge**

Spot Buy customers were unable to take advantage of a single harmonized TOU across all the Ariba Network suppliers.

Each participating supplier had its own terms of sale applicable to the Spot buy purchases. This made the evaluation process for buyers considering starting up the Spot Buy program a bit challenging.

# Meet that challenge with

#### SAP Ariba

For customers using the SAP Ariba Spot Buy solution, this feature introduces a new marketplace option within Spot Buy Admin Marketplace Tab called "Ariba Network". Customer procurement admins need to accept the TOU (harmonized across all Network suppliers) in order to activate the channel formerly presented as "Network Suppliers" in the Spot Buy Admin page.

## **Experience key benefits**

By accepting the new TOU, customers using Spot Buy program can retrieve catalog items uploaded by the Ariba Network suppliers and take advantage of a harmonized TOU across all network suppliers.

Buyers will no longer face the complexity of evaluating the terms of sale from individual suppliers participating in the Spot buy program.

# Implementation information

This feature is enabled for all SAP Ariba Spot Buy Catalog customers. Admins must accept the new TOU to access the Ariba Network suppliers channel for the Spot Buy solution.

# **Prerequisites and Limitations**

Customers must have a procurement card issued for spot buy purchases that will be used to settle the payments with the network suppliers.



Spot Buy customers can take advantage of the new Terms of Use (TOU) harmonized across all network suppliers who agreed to participate in the Spot Buy Program. In order to retrieve items from these network sellers procurement admins must accept the new TOU via the Spot Buy Admin.
