# Feature at a Glance Introducing: Component Consumption Enhancements

#### **Customer challenge**

There are no functionalities for duplicating an original item/component (flipped from PO/SA/SAR) and for removing a duplicated item/component during component consumption report creation - at item level it is not possible to report multiple consumptions/batches for a same material in one consumption report; at component level a supplier will have to transfer the static information manually (like part #) from one original component field to the added empty component field.

#### Solution area

# Meet that challenge with SAP Ariba

With the component consumption enhancements, suppliers can duplicate a line item or subcontracting component that was flipped from a purchase order, scheduling agreement, or scheduling agreement release. Certain field values are copied to the duplicate from the original (part number, UoM). In the report consumption report document the duplication of items and subcon components is enabled, in the ASN the duplication of subcontracting components is enabled with this feature. Also deletion of duplicated items/components is made possible.

#### Experience key benefits

Increase the efficiency during component consumption report creation and eliminate errorprone manual input. Allow to report multiple consumptions/batches for one item.

#### Implementation information

This feature is "on" by default for customers of **SAP Ariba Supply Chain Collaboration for Buyers.** No action is required to utilize this feature.

#### **Prerequisites and Limitations**

This feature requires that the buyer system has been entitled for SAP Ariba Supply Chain Collaboration and that a buyer administrator has enabled the supplier for SAP Ariba Supply Chain Collaboration.
