### Introducing: Mexico tax invoicing - initial support for payment receipt ("complemento de pago")

### **Customer challenge**

Mexican suppliers now must issue a new document type when they receive payments in installments or after invoice date. This way, Mexican tax authority is trying to avoid inappropriate cancellations through payment acknowledgment. Its use it is mandatory since August 31st, 2018.

- Buyers want to receive these payment receipts from their Mexican suppliers in a simple way prior legal validation.
- Buyers do not want to have a separate solution to manage these documents and ask for a single channel to receive and process them in alignment with the CFDI invoice flow.

## Meet that challenge with

### **SAP** Ariba

- Ariba now orchestrates the entire flow through 3rd party services
- Ariba Network enables a new option for suppliers to easily upload payment receipts in Ariba Network through a wizard-based process.
- All-in-one integrated solution to upload this new document type, run fiscal validations, display errors when applies, generate generic PDF when missing, and deliver to buyer via e-mail.

### Implementation information

- This feature is customer configurable:
  - Turning on the Mexico Tax Invoicing solution will also turn on this feature
  - If the Mexico Tax Invoicing solution is already on, this feature will come on automatically
- Main actions on Ariba side remain as before plus email configuration in the buyer profile.
- Training to Suppliers about business references required for each business scenario
- Vendor upload with their corresponding TAX ID and country code (MX).
- It only applies to Mexico-based Buyers and Suppliers and domestic invoices
- End-to-End testing is highly recommended.

### **Experience key benefits**

- Good experience for suppliers to deliver their payment receipts through the same guided process used for CFDI invoices in Ariba Network.
- Better customer experience by viewing and tracking all the invoices and payment receipts associated in one single platform.
- Ariba Support can fully support the entire process and walk suppliers through the solution when required.

### **Prerequisites and Restrictions**

On EDICOM side:

No configurations are required.

On Ariba Network side:

- Buyer side: Must have an active Ariba Network account and configure the tax ID.
- There must be an existing relationship between buyer and supplier in AN.
- Supplier side: Tax ID must be properly assigned to the supplier account during the Enablement process.
- TAX ID must be unique for buyer and suppliers so that it is assigned to only one AN account.
- No cXML transformation is done in AN at the moment.
- Suppliers do not have the ability to view the uploaded document after it has been submitted successfully.

## Complemento de Pago (Payment receipt)

### This is a new document type defined by Mexican Tax Authority (SAT):

- Payment receipts must be issued by suppliers when they receive payments in installments or after invoice date.
   This way, SAT is trying to avoid inappropriate cancellations.
- Its use is mandatory since August 31st, 2018 (after SAT announcements last February).
- Note this Mexico-specific document type was not supported by SAP Ariba platform.

### SAP Ariba now supports this country-specific document type

- These services are supported in Ariba Network. So, suppliers are able to upload CFDI invoices and payment receipts in Ariba.
- Buyer legal validations are performed for all the payment receipts through a PAC, and delivered to the buyer via e-mail.



## **Example**

- Line-item amounts are zero
- CFDI type = "P"
- Additional segment with payment details: payment date, mean, & method, among others
- Link to invoice via UUID

## New wizard-based process to upload & submit payment receipts



### **Legal Validations**

Suppliers see a new option in Ariba Portal to upload their CFDI invoices

Basic validations are performed to ensure consistency and then, buyer legal validations are run through a PAC service.

If any error, results and details are prompted for users to take proper action.

### **Upload PDF**


Optionally, users can upload their own PDF. Otherwise, the system automatically creates a generic representation according to the local layout.

### **Submit**

The payment receipt successfully validated is posted to the buyer via e-mail.

- Only valid documents are delivered to buyer
- Email for payment receipt delivery is configured in buyer profile page

## Initial phase for Payment Receipt flow (Complemento de Pago)



#### Manual upload in AN

Users now see a new option available in Ariba Network to upload their payment receipts (complemento de pago):

#### **Document Storage**

Documents are stored in the database


- Since the transaction document flow is kept for the next phase, currently documents will be only stored at this point.
- At this phase, No cXML transformation is done as the cXML transaction document schema has not been formalized yet.
- Also, suppliers do not have the ability to view the uploaded document after it has been submitted successfully.

#### **Email to buyer**


The payment receipt successfully validated is posted to the buyer via e-mail.

- Only valid documents are delivered to buyer
- Email for payment receipt delivery is configured in buyer profile page

#### **cXML** Transformation


Documents are stored in the database

- A new document type is supported via cXML in Ariba Network.
- Transformation to cXML is done in compliance with SAP and adapters.
- It is linked to invoices so that a report can be exported
- Also, suppliers have the ability to view the uploaded document after it has been submitted successfully.

#### **Buyer delivery**

The payment receipt successfully validated, the cXML payment receipt is delivered to the Buyer

- Business validations will be performed, and only valid documents are delivered to buyer
- Email delivery can be optionally configured in buyer profile page
