## Introducing: Ability to edit header-level fields on simultaneous amendments

### Customer challenge

Today, when a user changes an order using the simultaneous amendment feature, only line level fields can be changed. There are several instances, however, when the user might want to change header fields such as Need By Date and header custom fields. This may create more work for the user as well as introduce a different way of working compared to what they are used to.

This feature introduces the capability to edit header level fields on simultaneous amendments. Custom header fields can also be made editable.
