## Introducing: **Notify buyers about the expiry of the price validity of line items**

### Customer challenge

While buyers could request pricing from suppliers for a specified number of periods (months, quarters, or years) in CLIDs, they were not notified when the pricing validity of a contract line item in a CLID was about to expire.

### Meet that challenge with **SAP Ariba**

With this feature, the buyer can specify the number of days before the expiration of the contract line items pricing validity when the contract owner must be notified, so that the pricing validity information can be renewed. This information helps the buyer renew the pricing validity for those contract line items before their pricing validity expires.

### Experience key benefits

Allows buyers to proactively gather prices for items that are due to expire.

Buyers always have the latest prices for their items.

Notification on expiring prices will be sent to contract owners at the start of the renewal period for the respective terms (30 days in the above example).

Notifications on expiring prices for line items will also be sent for items that are missing pricing information. In the above example, the contract owner will be notified to update price info for the July 2019 period at the start of the renewal period.
