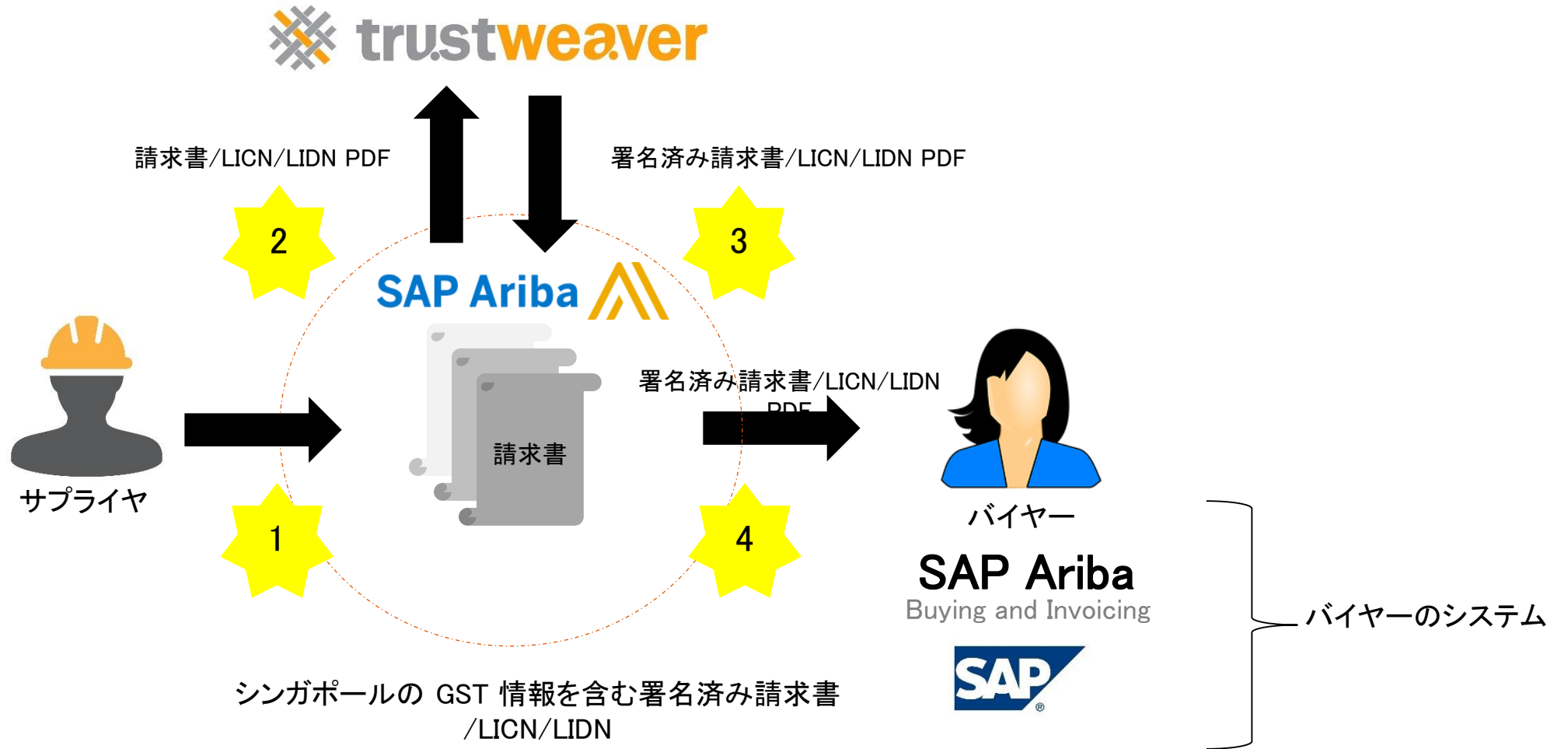

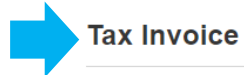
プロセスフロー

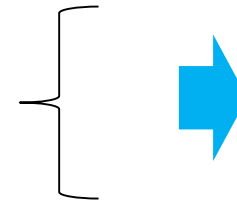

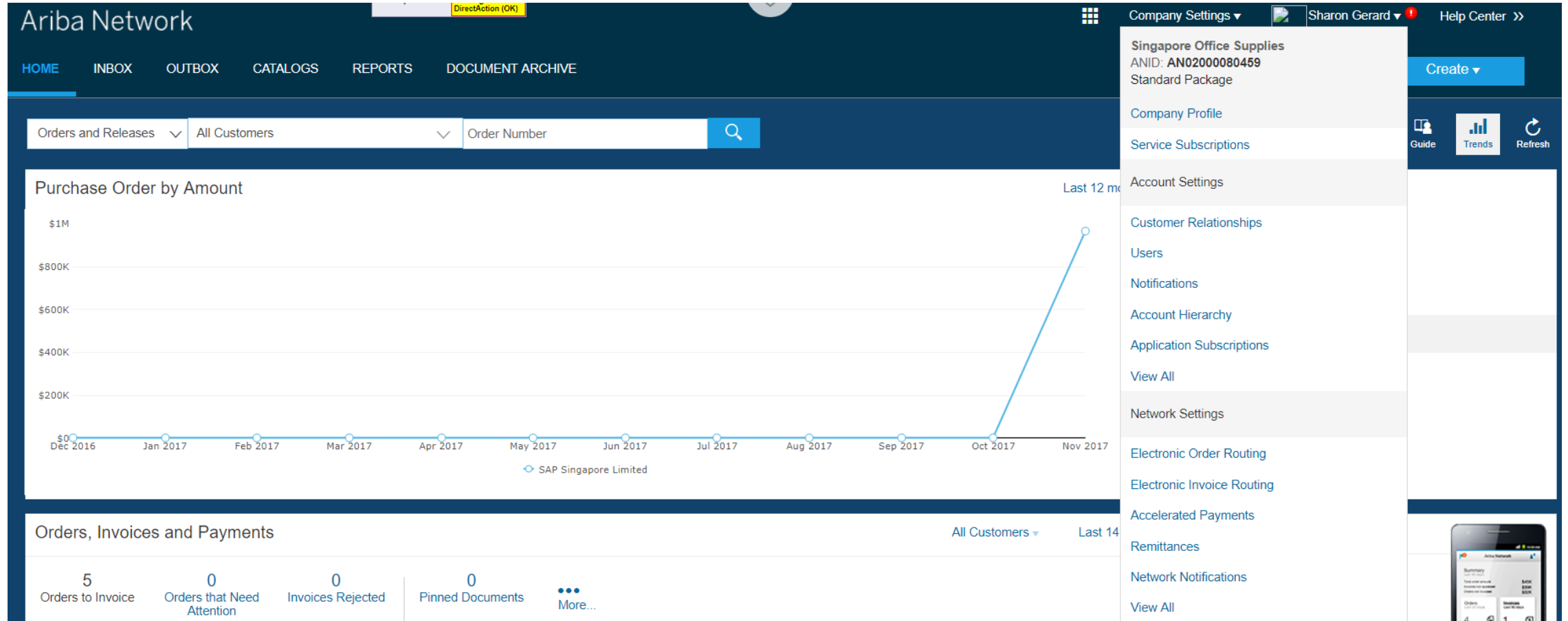
