Introducing: Support for lean services procurement in Guided Buying

Customer challenge

Lean services procurement is typically suited for procurement of simple services that do not require detailed specifications thus resulting in decreased time and resource requirements.

SAP Ariba customers (with SAP S/4HANA Cloud backend solution) cannot currently procure lean services using the SAP Ariba Guided Buying user experience due to lack of seamless integration between the two solutions.

Meet that challenge with

SAP Ariba

This feature introduces the lean services procurement process as an integration scenario with SAP S/4HANA Cloud solution. It involves creation of service requisitions in Guided Buying and creation and processing of follow-on documents such as purchase orders, service entry sheets, goods receipts and invoices in S/4HANA.

Users can monitor the progress of procurement by reviewing the status of follow-on documents created in SAP S/4HANA by viewing the entries recorded in the history of the service requisition.

Lean services can now be procured using the Guided Buying user experience in SAP Ariba solutions for SAP S/4HANA integrated sites.

Prerequisites and Restrictions

Lean services in SAP S/4HANA can be planned lean services or limit items for unplanned lean services. This release supports only planned lean services in guided buying integrated with SAP S/4HANA Cloud.

Pre-requisites

SAP S/4HANA supports this feature for the following integration scenarios:

- Supplier master data must be imported from S/4HANA to SAP Ariba Guided Buying to select appropriate suppliers for service items.

Restrictions


- Changes made to field values on purchase orders in SAP S/4HANA are not synced with the corresponding fields on requisitions in guided buying.
- Supplier collaboration and request for proposals is not supported for lean services items.
- In the current release, users cannot specify maximum and expected amounts for service items on requisitions. Further, notifications on the dashboard do not include status information for requisitions consisting of lean services items. Users can view status information about a requisition only by viewing the History record of the requisition.



Following is the basic flow for Lean services integration between SAP Ariba Guided Buying and SAP S/4HANA




