Feature at a Glance Introducing: Enhancements to engagement task management

Customer challenge

The owner of control review tasks and To Do tasks on questionnaires are typically project groups that represent groups of people who can potentially complete the tasks. However, it is often desirable to have specific individuals complete these tasks in specific engagement projects, with the flexibility to assign and reassign tasks. Additionally, a user needs to know which tasks they are to perform and when these tasks are due to properly prioritize work.

This feature introduces the ability to assign "to do" survey tasks and control review tasks to an individual user or for the user to return the task to the group. The engagement list page provides a new column showing the number of tasks assigned to the user or accessible to the user as part of the group linking to the new task list view.

The task view shows the specific tasks within the engagement the user can access either as the specific owner of the task or as a member of the assigned group. Actions to open or assign the tasks can be taken from the task list view.

Experience key benefits

Users can easily find engagements that require task actions either specifically assigned to them or accessible as the member of a group assigned a task as well as see tasks that are due soon.

The task list view provides an easy way for task owners and group members to manage tasks assigned to the specific user or group by surfacing the assigning, claiming, reassigning or returning of tasks to the group actions outside of the engagement view.

Tasks can also be opened from the task view where the same assigning actions can be accessed or the task can be performed.

Prerequisites and Restrictions

Control-based engagement risk assessment projects must be enabled in your site.



Detailed feature information: This feature introduces the following new buttons to the details pages for To Do tasks on questionnaires and control review tasks in engagement risk assessment projects: assign and assign to me. These buttons open new popups that allow you to assign the task to yourself (for Assign to me) or assign or reassign the task to another member of the project group or the project group itself (for Assign) and add a comment explaining the assignment.



Tasks are listed based on ownership - if

Detailed feature information:



Action menu opens actions available to the user depending on the status of the task (view vs. start) and task assigning actions if available.

Control review and To Do tasks can be assigned by a group member to another group member or claimed by a user in the group thereby moving the task into the My tasks tab.

Tasks assigned to a user can be reassigned by that user to another user in the group or returned to the group thereby moving the task back to the Group tasks tab.

Single actions are shown with a button directing the user to the available action

Additional Prerequisites

To assign or reassign a control review or supplemental engagement questionnaire To Do task, you must be a decision maker for the control (for control review tasks) or a task owner (for To Do tasks) or a member of the Supplier Risk Engagement Governance Analyst group.

To be eligible to be assigned a control review task, you must be a member of the project group defined as its decision maker. To be eligible to be assigned a questionnaire To Do task, you must be a member of the project group that owns the task.

Currently, task assignment is only supported for control review tasks and To Do tasks on questionnaires in the engagement project.
