Introducing: Enhancements for sending external assessment questionnaires

Customer challenge

SAP Ariba Supplier Risk today sends a notification to all the supplier contacts when a supplier facing risk assessment is sent out.

The business users or the engagement request owners are not able to select a single supplier contact who should be assigned the supplier risk assessment. All supplier contacts are assigned to the risk assessment.

Meet that challenge with SAP Ariba

Suppliers facing risk assessments in a control based engagement risk project will be assigned to supplier's primary contact by default.

Business users or the Engagement request owners are able to update the recipient of the risk assessments from the primary contact to another supplier contact.

Experience key benefits

Assessments and notifications can now be sent to the supplier primary contact only. This will help with clear assignment of duties, where one named supplier contact can be assigned to risk assessments instead of a group of supplier contacts.

This capability reduces duplicate efforts and confusion because now a single supplier contact can receive notifications to complete risk assessments.

Prerequisites and Restrictions

Control-based supplier engagement risk assessment projects must be enabled in your site.

The advanced send assessments workflow self-service parameter, Application.SR.Engagement.EnableAdvancedSendAssessment, must not be enabled in your site.

Feature at a Glance

Introducing: Enhancements for sending external assessment questionnaires

1. The supplier's primary contact assigned as the recipient of risk assessments by default.

2. Engagement project team can click **Change recipient before sending the risk assessments out to the supplier.**

3. User can select one of the supplier's contacts as the recipient for supplier facing risk assessments

4. Recipient is updated with the new selection. Risk assessments are assigned to the selected recipient.
