Starting August 24 (August 25 local APAC time), Alphabet/Google will transition to a source-to-pay technology solution from **SAP Ariba¹. This change is part of a multi-year transformation that will simplify the end-to-end buying process for us and our suppliers. Initially, this transition will change how you receive purchase orders, submit invoices, and manage your supplier account information with Alphabet/Google (for more details on transacting purchase orders and invoices on SAP Ariba for your country, please refer to this guide).

WHAT THE TRANSITION TO SAP ARIBA MEANS FOR YOU

We are requesting our suppliers based in Asia-Pacific to register an SAP Ariba** Network account to transact with Alphabet/Google. You have two account types to choose from: standard (<u>free</u>) or enterprise (<u>fee-based</u>). When you first register with SAP Ariba, you will be defaulted to a free

standard account. You can choose to <u>upgrade</u> to a <u>fee-based</u> enterprise account at any time. For more details on SAP Ariba account types and enterprise fees, please visit <u>this site</u>².

Option 1: Standard (Free) Account

You can also choose a free standard account with basic functionality if this better meets your business needs.

If you choose a standard account, no action from you is required at this time. You will receive more details about how to register a standard account when you receive your first new purchase order from Alphabet/Google beginning August 24.

Option 2: Enterprise (Fee-Based) Account

After registering your standard account, you will have the option to <u>upgrade</u> to a <u>fee-based</u> enterprise account that offers enhanced functionality and SAP Ariba customer support.

NOTE: All parent companies and subsidiaries/affiliates for your organization that do business with Alphabet/Google entities based in North America, Europe, the Middle East, Africa, Latin America and Asia-Pacific will also transition to SAP Ariba.

CHANGES TO UNDERSTAND

Starting August 24, you will use SAP Ariba to...

- 1. Receive NEW Purchase Orders (NEW POs are those created after August 24)
- 2. **Submit NEW Invoices** (Existing POs created before August 24 should be invoiced through current channel)
- 3. Manage Supplier Information with Alphabet/Google such as your bank account, address, and account administrator (This is a separate process completed by supplier after go-live; more details to come)

Anticipated benefits to you from these changes:

- 1. Higher degree of data accuracy from supplier account self-maintenance capabilities.
- 2. Real time PO and invoice delivery for quicker fulfillment and easier payment.
- 3. Real time PO and invoice status updates on your SAP Ariba supplier account dashboard.

Starting August 24, you will receive new purchase orders from Alphabet/Google via email from ordersender-prod@ansmtp.ariba.com. Please add this mailer to your safe senders list to ensure the purchase order is successfully delivered. **Upon receipt of your first interactive email purchase order, please complete the following steps to set up your account and confirm your trading relationship with Alphabet/Google:**

- Select the "process order" button and choose the "sign up" option to create a new standard account, or choose the "log in" option if you already have an existing SAP Ariba standard account that you would like to use.
- 2. Enter your account details and purchase order routing email address, accept the terms of use** and click on the "register" button.
