Feature at a Glance Introducing: Disable SAP Ariba Mobile app activation

Customer challenge

Many customers would like to disable activation of the old Ariba Mobile app before rolling out the new SAP Ariba Procurement app. At present, there is no way to do so.

Meet that challenge with SAP Ariba

A new self-service parameter is available which will disable activation of the old SAP Ariba Mobile app for all users in the effected realm.

Experience key benefits

Customers can restrict their users from activating the old SAP Ariba Mobile app The old app is in maintenance only mode and planned for deprecation in the future.

Implementation information

Customer administrators can activate this new parameter for the specific realms in which SAP Ariba Mobile app activation should be disabled. Once the parameter is activated, users in that realm will no longer see the option to enable the old SAP Ariba Mobile app in the Activate Mobile Device page.

Prerequisites and Restrictions

The new parameter only turns off new activations of the old mobile app. It does not deactivate the existing activations performed before the parameter was turned on.

Detailed feature information

- Customer Administrators are able to turn on a new self-service parameter that will remove the option to activate the old SAP Ariba Mobile app and the activation code input field from the Ariba web application mobile device activation page.
- The new parameter is called Application. Mobile. DisableSAPAribaMobileAppActivation.
- Default value for this parameter is Off (No).
- Customer Administrators are able to turn the parameter off again after turning it on. The option to activate the old SAP Ariba Mobile app and the Activation Code input field will reappear.
- Once the parameter is turned on the mobile device activation page will not show any reference to the old SAP Ariba Mobile app.

Introducing: Improved handling of attachments to approval e-mails from SAP Ariba Contracts and SAP Ariba Sourcing

Customer challenge

When email approval is enabled, SAP Ariba system sends, in the approval email, the files to approve, irrespective of their sizes. Email servers and infrastructure do not support large attachments, and that ends up in lost notifications and clogged email servers and clients.

Meet that challenge with SAP Ariba

Now, when the size of files to approve is too big, we send links to the files, instead of attachments.

Experience key benefits

Lighter emails will make less notifications lost, while users retain the ability of easily accessing what is being approved.

Implementation information

This feature is **automatically on** for all customers with the applicable solutions and is ready for immediate use.

By default, the threshold size is 15 MB. Customers can change that default (up to 25 MB) via the ICM parameter, Application.ACM.FileSizeLimitForEmailAttachments.

Prerequisites and Restrictions

Requires ICM parameter for email approval, Application.Base.EmailApprovalEnabled, be enabled.

Detailed feature information

When the overall size of attachments to be included in the email is too big, approvers no longer receive the attachments in the email, but as a link to the system.

The threshold to send the attachments as a link or as an attachment can be configured – default value is 15 Mb.

When the attachments' size is below the threshold
