Introducing: Support for push notifications to purchase requisitions approvers

Customer challenge

In earlier releases of the SAP Procurement mobile app, push notifications related to purchase requisitions are not supported.

Purchase requisition approvers who use the procurement app rely on email notification to know about requisitions pending their approval, which is not consistent with our vision for the SAP Procurement mobile experience.

Meet that challenge with SAP Ariba

This features introduces push notifications related to purchase requisition in SAP Ariba Procurement mobile app.

Approvers receive notifications when:

- Requisition assigned for approval
- · Requester sends reminder (Nudge)
- Requester withdraws a requisition

Experience key benefits

Push notifications alert approver immediately when there is a new requisition that needs approval, improving their user experience and reducing approval cycle time.


Prerequisites and Restrictions

Prerequisite: must have downloaded the SAP Ariba Procurement app to your mobile device and have received an email with the required sign-in information.

<u>Prerequisite</u>: must belong to the Ariba Mobile User group in order to use the SAP Ariba Procurement mobile app.

<u>Restriction</u>: at this time no push notifications related to requisitions are displayed to requesters.


