**IMPORTANT: Update on Ariba Network Transition Timeline** 

Dear Valued Supplier,

You are receiving this communication because you have provided goods and/or services to Corteva Agriscience's Crop Protection business platform in North America.

As previously communicated, Corteva is partnering with SAP Ariba® to fulfill our vision of moving away from paper and manually transmitted documents.

## **Updated timeline**

As an organization, we have adjusted the implementation timeline to coincide with customer-facing projects. Therefore, October 1, 2021 is the new Ariba "Go Live" date for the North American Crop Protection business platform. (Our North American Seed business platform will go live in Summer 2022).

In the meantime, please continue to transact with Corteva and its affiliates in the same manner as you do today. There will be no changes in purchase orders and invoicing until the North American Crop Protection business platform goes live on the Ariba Network on October 1, 2021.

We will be in touch with more information before the new "Go Live" date.

If you have already signed up for an Ariba Network account, please save your username and password for future use. Enterprise account owners -- be aware that no fees will be accrued due to your relationship with Corteva until we start transacting on the Ariba Network (standard accounts are always no-cost). If you do *not* already have an Ariba Network account, please visit the <u>Ariba Supplier Portal</u> to learn more and identify the best account type for you.

If your company has been engaged regarding Ariba Supplier Management, note that this transition will also be delayed until October 1, 2021. (Additional communication to follow.)

Note: If your company is also a *customer* of Corteva or if you have special legal agreements with Corteva, you can expect to receive additional targeted communications that might require further action.
