**IMPORTANT: Update on Ariba Supplier Management**

Dear valued supplier,

You are receiving this communication because you support Corteva Agriscience's North American Crop Protection business platform\* and will be transitioning to Ariba Network for supplier onboarding and engagement. We call this initiative Supplier Management or Supplier Lifecycle Performance (SLP).

As previously communicated, Corteva Agriscience is partnering with SAP Ariba® to fulfill our vision of an end-to-end digital procure-to-pay process with suppliers.

**Updated Timeline**

**We are adjusting the Ariba implementation timeline to coincide with customer-facing projects. Therefore, October 1, 2021 is the new “Go Live” date for Supplier Management through Ariba Network.**
