Based on Industry and Process customers want to control which options are available for the supplier to edit auto packed packing structures

The feature provides a list of new configuration options within the Handling Unit profile for Ship Notices, as also enhances the structure of the packaging instruction excel sheet to enable specific assignment of auxiliary materials to single packaging materials.

The assignment tab of the packaging instruction excel template supports now validity period information for an more advanced determination of packaging instructions.

Experience key benefits

This feature provides more advanced packaging tasks that a buyer administrator can enable in a supplier's handling unit profile.

In addition validity periods of packaging instruction can now be used within the process.

Detailed feature information

This feature provides more advanced packaging tasks that a buyer administrator can enable in a supplier's handling unit profile.

Buyer/supplier side enhancements

- New handling unit profile rules
 - Enable suppliers to edit values on define instruction screen
 - Enable suppliers to edit the dimensions values of handling units
 - Enable suppliers to add empty packaging material to a handling unit
 - Show auxiliary materials in auto packaging
 - Enable suppliers to remove auxiliary materials in auto packaging
 - Enable suppliers to add auxiliary materials in auto packaging
 - Enable suppliers to add packaging materials as auxiliary material
- Support of validity period

Auxiliary Material Enhancements


- Auxiliary Materials can now be extracted for specific packaging level
 - Column "Parent Packaging Material" will be used in packaging instruction to handle the assignment
 - E.g. a "Foil" can be assigned to the packaging material "Carton" only
- Auxiliary Materials can now be considered for auto packaging
 - Quantity of each auxiliary material will be taken from the packaging instruction
 - If auxiliary material is enabled for auto packaging it can be controlled by separate rules, if:
 - Additionally auxiliary materials can be added
 - Or auxiliary materials added by auto packaging could be deleted
- Packaging materials can be used as auxiliary materials on the related level
 - Will be enabled/disabled by a separate rule
 - E.g. an "Carton" could be added as a auxiliary material on the same level



Introducing: Additional advanced packaging tasks for handling unit profiles

Edit of HU Dimensions

- By a new rule buyer can enable supplier to edit dimensions of a packaging material
 - Available on Define Instruction and Confirm packaging Screen
 - Available packaging and auxiliary materials
 - Editable fields: Length, Height, Width, Net Weight, Gross Weight
 - Limitation: Unit of Measure is not editable to ensure it fits to master data from packaging instruction



Introducing: Additional advanced packaging tasks for handling unit profiles

Add Empty Packaging Materials

- By a new rule buyer can allow supplier to add empty packaging materials after auto packaging
 - Is available for all inner levels, e.g. on the carton and the box, but not on the pallet
 - The most outer level will still be handled by add "Handling Unit" button
 - If the rule is enabled packaging materials with 0 quantity will not be removed
 - Available via "+" button






Introducing: Additional advanced packaging tasks for handling unit profiles

Support of Validity Period and Control editing values on define instruction screen

- Validity period of a packaging instruction can now be controlled
 - New columns "Valid from" and "Valid to" will be added to "Assignment" tab in packaging instruction
 - No standard export in CSV extract from CIG-Addon, like for the other fields on "Assignment" tab
 - Fields are both optional, also only "Valid from" or "Valid to" single values will work
 - If fields are not filled validity of a packaging instruction is not limited (actual default behavior)



• A new rule is available to disable all editable fields on define instruction screen for supplier
