Support for publishing public procurement notices on the Tender Electronic Daily (TED) portal

Description

- According to the European Union (EU) public procurement law, as part of the tendering process, a public entity must publish notices on the Tenders Electronic Daily (TED) portal. The notices contain important information, including bid items, time frame, location, selection criteria, and awarding criteria.
- Public entities based in the European Union and in the European Economic Area can now publish the following types of notices to the TED portal:
 - Prior information notice (PIN)
 - Contract notice (CN)
 - Contract award notice (CAN)
 - Periodic indicative notice utilities (PIN Utilities)
 - Contract notice utilities (CN Utilities)
 - Contract award notice utilities (CAN Utilities)
 - Corrigendum cotice (change notice)


- This feature is supported only in guided sourcing. To use this feature, your site must have guided sourcing enabled and you must be a member of the Category Buyer group.

Restrictions

 Integration between guided sourcing and the TED portal must be configured using SAP Integration Suite, managed gateway (Feature IG-32935)

- Preparation and publication of notices on TED fully integrated with SAP Ariba Sourcing
- Predefined and prefilled procurement notice templates according to legal rules
- Management of TED portal responses and initiation of subsequent process steps
- Support of the following key notices for classic public sector and special sectors:
 - Prior information notice
 - Periodic indicative notice
 - Contract notice
 - Contract award notice
 - Corrigendum notice



User story

- As a buyer administrator, you can associate public procurement notices with a public sector event template.
- As a buyer, you can enter procurement details in the notices associated with the event and publish the notices on the Tenders Electronic Daily (TED) portal.
- As a supplier, you can view the notices on the portal and the related event details on a public access page. You can invite yourself to participate in the event after registering on SAP Ariba Discovery.
