## Automatic deletion of inactive budget data

#### Description

This feature enables automatic deletion • of inactive budget records that are not referenced by any approvable document.

### **Customer benefit**

- As budget records are updated frequently, the inactive records might rapidly grow in storage size and prevent further updates.
- This feature prevents inactive budget records from causing these challenges and provides:
  - Improved performance
  - Reduced administrative overhead
  - Fewer budget load issues

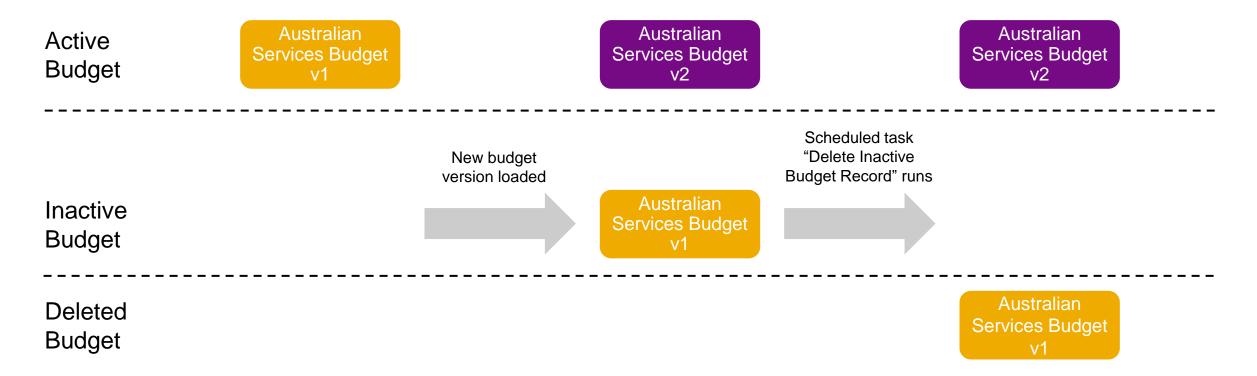

## **Feature details**

- When a budget record is modified, a new version of the budget record is created, and the previous version becomes inactive.
- Currently, inactive budget records are not deleted automatically. As of the 2302 release, inactive budget versions without any reference will be deleted after the "Delete Inactive Budget Record" scheduled task is automatically run.
- The diagram below gives you an overview of how budgets are loaded, inactivated, and deleted.
- Note that no transactional documents will be affected by budget deletion.
