

Ariba Network calculates invoice exception rate time by counting invoices with rejected, cancelled & failed status and by counting the number of debit & credit memos. The sum of this transaction count is divided by the number of invoices sent to your customer.



 - enter DUNS number and get the company name and address from D&B
 - Once user verifies and Accept the company name and address information populated from D&B, it will be auto filled on registration form.
 - If the D&B populated information is not correct or not the company you belongs to:
 - Select Use a different DUNS number to go back and edit/change the DUNS number

OR

- Select Skip to get back to registration form to register without DUNS number
- Ignore DUNS number and create account as its not a mandatory field

Existing account without DUNS number

- On Marketing profile, user can add the DUNS number (if known) or do a look up to find their DUNS.
- On DUNS number field:
 - enter DUNS number and get the company name and address from D&B
 - Once user verifies and select OK, the company name and rest of the information is prepopulated on the respective fields once user review and accept it and move to next tab with address information to Accept the information.
 - If the D&B populated information is not correct or not the company you belongs to:
 - Select Use a different DUNS number to go back and edit/change the DUNS number
 - User can also select **Decline** if the DUNS populated information is not correct and update company profile manually and save it.
 - Ignore DUNS number and update account as its not a mandatory field


User Story – Sustainability ratings on trading partner profiles

User Story: As a Supplier, I want to showcase my sustainability ratings on my BN Marketing profile to increase trust with buyers.

Suppliers, also known as Trading Partners, can maintain their sustainability ratings on their Marketing Profile Page on the Trading Partner Portal. SAP Business Network Trading Partners can also request to get rated by EcoVadis through the SAP Store.

Trading Partners can self-report their sustainability ratings by selecting 'Enter rating'. Additionally, SAP and EcoVadis have expanded this capability further with integration that allows trading partners to display their EcoVadis badge on their SAP Business Network marketing profile, adding verification from EcoVadis and a layer of certainty for Buyers.

Buyers can search and discover Trading Partners based on these ratings, enabling them to assess trading partners and take immediate action that impacts the sustainability of their value chains.

User Story



Packaging and Handling Unit processes are quite diverse based on industry and customer requirements. Therewith there is the need to allow a set of flexibility and control to configure the behavior of the network.

Based on industry and company size the number of available packaging specification could be quite big, like hundreds or thousands of versions. Therefore, it might be that every several or at least one of the packaging instructions will be updated frequently. A manual update in this frequency would be to cumbersome.

The feature enabled you to handle automated replication of packaging instructions from S/4HANA backed system for initial load of the entire set of available packaging instruction, as also for case of creation of new packaging instruction and update of existing ones.

This comes along with multiple filter options to control the selection of packaging instruction to be considered for replication.




