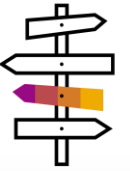
# User Story

**User Story:** As a Supplier, I want to showcase my sustainability ratings on my BN Marketing profile to increase trust with buyers.

Suppliers, also known as Trading Partners, can maintain their sustainability ratings on their Marketing Profile Page on the Trading Partner Portal. SAP Business Network Trading Partners can also request to get rated by EcoVadis through the SAP Store.

Trading Partners can self-report their sustainability ratings by selecting 'Enter rating'. Additionally, SAP and EcoVadis have expanded this capability further with integration that allows trading partners to display their EcoVadis badge on their SAP Business Network marketing profile, adding verification from EcoVadis and a layer of certainty for Buyers.

Buyers can search and discover Trading Partners based on these ratings, enabling them to assess trading partners and take immediate action that impacts the sustainability of their value chains.

- If the supplier has been rated by Ecovadis, they can import their ratings using this option. The supplier needs to have a valid DUNS number on their profile to import their ratings.
