#### Law Reference for Exempt Trade -Reverse Charges

• In most countries, a law reference and explanation is required for tax exempt trades. For example, in the EU invoices for all reverse charge trades need additional statements indicating that the liability for the payment of VAT is reversed to the recipients. In SAP Business Network, suppliers use the Tax Detail, Description, and Law Reference fields in the invoice to capture the explanation and law references

## Switzerland - QR Reference

- For a Swiss supplier when setting up the remittance address details (bank account details), the supplier most choose the correct IBAN type.
- This relates to two processes:
  - IBAN is required if the supplier does not provide a QR reference to Ericsson
  - QR-IBAN if the supplier does provide the QR code to Ericsson
- Go to the initials on the top right, choose Settings, then Remittances, then EFT/Check Remittance and choose Edit or Create



## Switzerland - QR Reference

- Please note that if a supplier does not provide a QR-IBAN reference this will not be needed
- The field will only appear when the supplier selects remittance QR-IBAN
