
Option to Hide Non-Catalog Shopping Categories in SAP Ariba Procurement Mobile App [BMA-5091]

Adding Non-catalog items to requisitions in SAP Ariba Shopping Mobile App [SAS-55]

Description:

With this feature, users can add non-catalog items to their requisition and submit a purchase requisition that has a non-catalog item as a line item.

The non-catalog item request form consists of seven fields, six of which are mandatory. The user provides input to these fields, describing the item that doesn't belong to the catalog. The user can add the non-catalog item to the cart by creating a new purchase requisition or adding it to an already existing purchase requisition. Checkout details apply at the header level to all catalog and non-catalog items. Non-catalog items that have been submitted are described as non-catalog items in the purchase requisition details.

By leveraging SAP Ariba's non-catalog functionality, this feature will now enable SAP Ariba Shopping mobile app users to create or add items to a requisition that do not belong to the catalog.






Email Notification Updates for Third-Party Provider Dun & Bradstreet [ARI-21011]


Ability To Transfer Mapped Information of Top BOM Item in Product Sourcing BOMs to Sourcing Events [DMS-18661]

Description:

This feature enables the transfer of top BOM item information in product sourcing BOMs, which is mapped to specific terms in SAP Ariba Sourcing project templates, to sourcing events when buyers create a BOM quote. This information, in addition to the standard BOM information obtained from product sourcing, helps buyers to create a price acceptance scenario successfully for awarding the sourcing event.

Customer Benefit:

The "OrderUnit" field is accessible for Material Quotes but is not functional for BOM Quotes. In the context of a BOM Quote, it is necessary to establish a mapping for the "term" field for both the header and lot items.


Prevent Adding Deleted Materials to Product Sourcing Events [DMS-18783]

Description:


Disable Reply-To header field [SS-50729]

Description:

This feature disables (excludes) Reply-To fields in email message headers sent by SAP Ariba. Some buyer and supplier mail systems may block email messages with Reply-To fields. By disabling Reply-To fields, this feature may enable buyers and suppliers to receive previously blocked email sent from SAP Ariba.

Customers use external third party network/email spamming scanning tools to identify spam and phising emails inside their internal networks which causes Ariba emails to be blocked. This can be avoided by disabling the Reply-To header field in emails.
