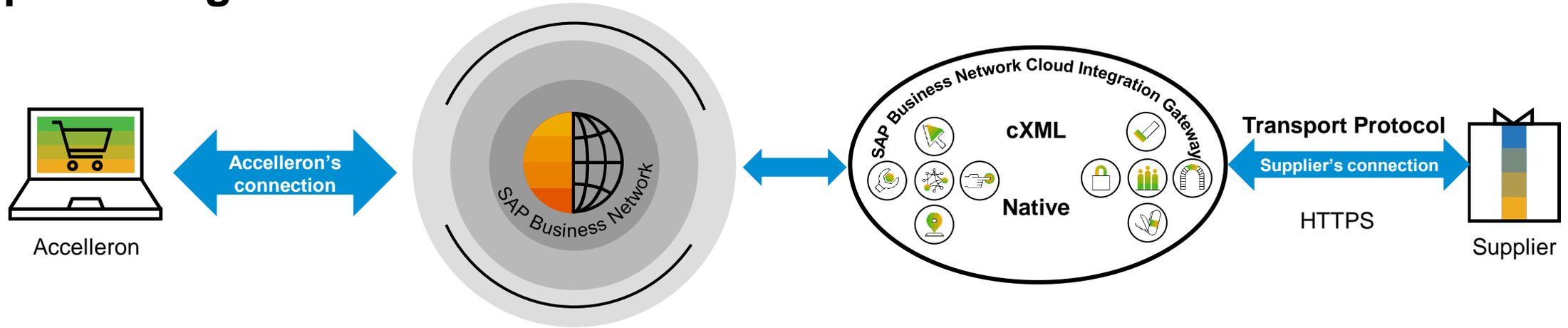

# Supplier CIG general considerations

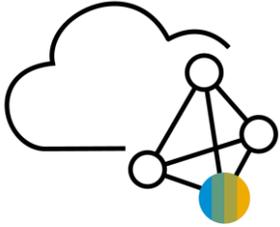


- Please, note that CIG **will not “touch”** the Supplier’s internal back-end system.
- *For example*, in case the supplier is integrating a PO sent by Accelleron what the supplier will need to provide is an *URL where they would like to receive this document*:
  - When Accelleron is sending the PO, the file will be *transmitted in real-time to the URL* of the supplier.
  - It will be the *responsibility of the supplier to take the PO* from their internal URL and import it in the system of their own internal choice
  - *Consequently, all the Supplier’s Internal approvals/processes will be applied to that document in the Internal Supplier’s Back-end System*
- Also if the supplier would like to integrate Advance Ship Notice, for example, they will need :
  - to prepare, internally, the Advance Ship Notice file according to requirements presented in the Accelleron Seller Integration Guidelines
  - To export the file from their internal environment/back-end systems and place it in the URL indicated by SAP Ariba Team / CIG configurations
  - From there the file will be processed according to the standards steps, and if compliant with all Accelleron’s requirements, will be delivered in real time to Accelleron
- *Please note the above picture is not an actual technical architecture but an illustration meant to create a general understanding. The architectures on the suppliers side are different and vary case by case as each supplier is free to chose his internal applications, solutions, middleware, service providers, ERP, etc. Please note as well that Accelleron CIG and Supplier CIG do not perform the same functions.*



# Integration with cXML

## ■ SAP Business Network language:



- The native language of SAP Business Network platform is **cXML**.
- cXML is an open standard created by SAP Ariba and the general specifications can be found on <http://cxml.org/>
- Please refer to the specific generic cXML documentation found on <http://cxml.org/>  
Please note that the documentation from <http://cxml.org/> is not Accelleron specific.  
Separate Accelleron specific documentation – Integration guidelines will be provided, representing basically a “sub-set” of the documentation from cXML.org

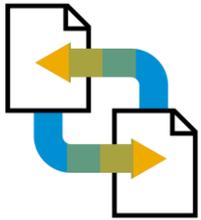
## ■ Transport protocol :

- cXML is supported through **HTTPS** transport protocol.
- Suppliers web server must support at least **TLS version 1.2**



# Cloud Integration Gateway: HTTP/S transport & security

- **CIG Support HTTP/S transmissions both ways, for cXML integrations.**



The cXML payload is always sent with UTF-8 encoding.

File attachments are encoded in base64, within MIME envelopes.

- **CIG supports 2 types of Authentication modes with HTTPS**



- **HTTP Basic**

- Via a username and a password

- **Certificate based**

- CIG only accepts certificates issued by a trusted authority (self-signed certificates are not acceptable).
- Trusted certificate authorities list can be find on SAP Ariba Cloud Integration Gateway “how to guide” for suppliers (will be provided after the call).



# Pre- requisites to Supplier Cloud Integration Gateway

- An active Supplier account on SAP Business Network ( Test and Production )
- A valid trading Accelleron - supplier relationship on SAP Business Network ( Test and Production ).
- Ensure Ariba specific IPs are authorized on supplier's Firewall.
- Ensure Ariba specific URL domain (\*.ariba.com) is authorized.
- Ensure Ariba email domain (\*.ariba.com) is authorized.

## What you will need to prepare on your side as Supplier for the first step :

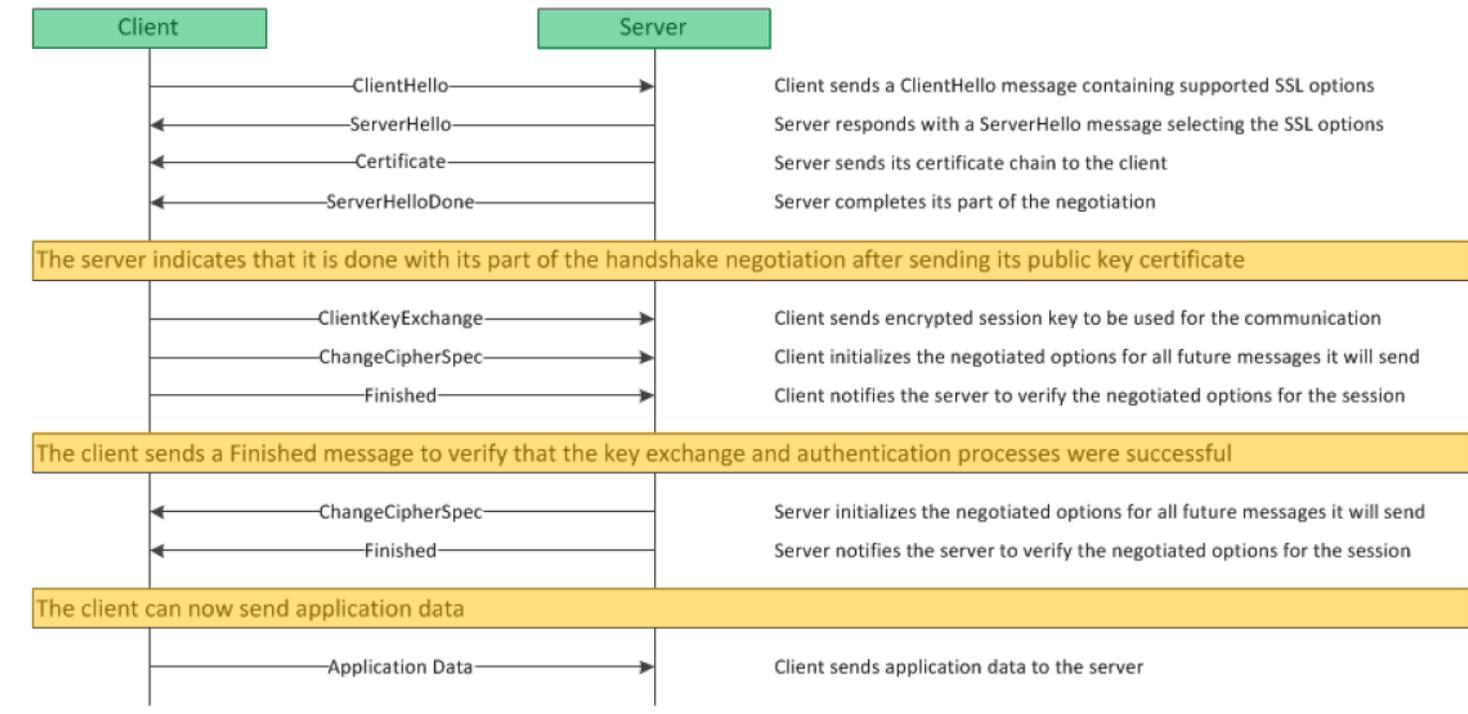
- The URL where you would like to receive the documents you have in scope with Accelleron ( we recommend one for Test and one for Production )
- Chose what authentication method you would like to use : Basic or Certificate

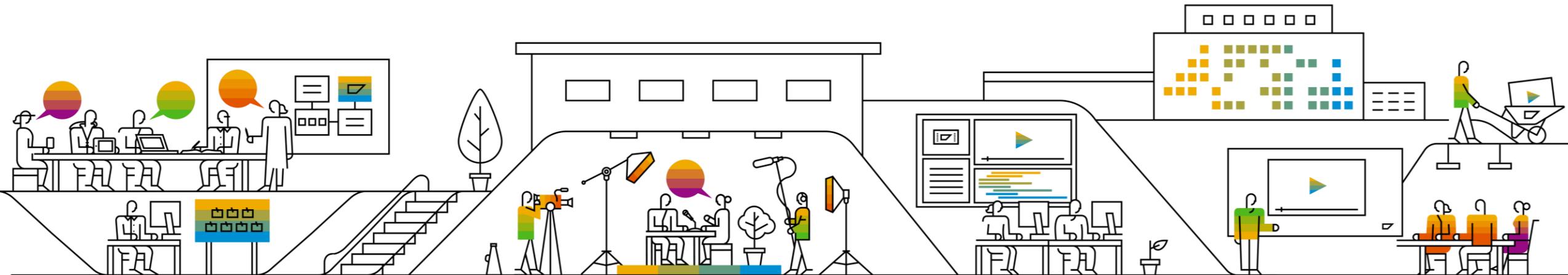
# SSL handshake overview

- SSL communication consists of a series of messages exchanged between two parties (client and server).
- The SSL handshake between a client and server consists of nine steps, and appears as follows:
- The SSL messages determine the parameters of the encrypted communication channel that the two parties plan to use. It is important that the client and server agree on the message details, such as the protocol version, cipher suites, secure renegotiation, or client certificate requests. Otherwise the handshake fails.



- For example, to keep the case presented above, in case the supplier is integrating the **PO** sent by **Accelleron**, :
  - *CIG* initiates the communication and is the *Client*
  - *Supplier Web Server* is the *Server*

# Frequently asked questions

Question	Answer
Is SAP Business Network “touching” the internal back-end system / middleware of the supplier ?	No it does not.
Is there a specific requirement coming from SAP Business Network for the supplier to use a specific ERP / ERP version ?	No. SAP Business Network does not have requirements or limitations related to the ERP / ERP version used by the supplier. That because the Supplier’s ERP / ERP version is basically not transparent to the SAP Business Network. As long as the supplier is able to process the files in the specification of Accelleron project and provide back files that comply with the Accelleron specification as requirements the actual back-end of the supplier is not transparent for the project.
Is SAP Business Network requiring the suppliers to use / purchase a specific middleware / third party provider in order to complete the seller integration ?	No. SAP Business Network does not have requirements or limitations related to the middleware / third party provider that the supplier is using. The suppliers are free to chose whatever integration solutions, applications, middleware's or service providers are better suited for their internal polices. As long as the supplier is able to process the files in the specification of Accelleron project and provide back files that comply with the Accelleron specification as requirements the actual middleware / third party provider of the supplier is not transparent for the project.
Is the SAP Business Network team, the SI team, part of the internal mappings that take place internally on Supplier’s side ?	No. Please note the SAP SI is not part of the internal mappings that take place on the supplier’s side. Please note that the SAP SI will not be in a position offer any type consultancy in terms or internal supplier mappings, supplier ERP processes, supplier middleware, etc. It will be the responsibility of the supplier to find and engage the necessary resources for their own internal project .

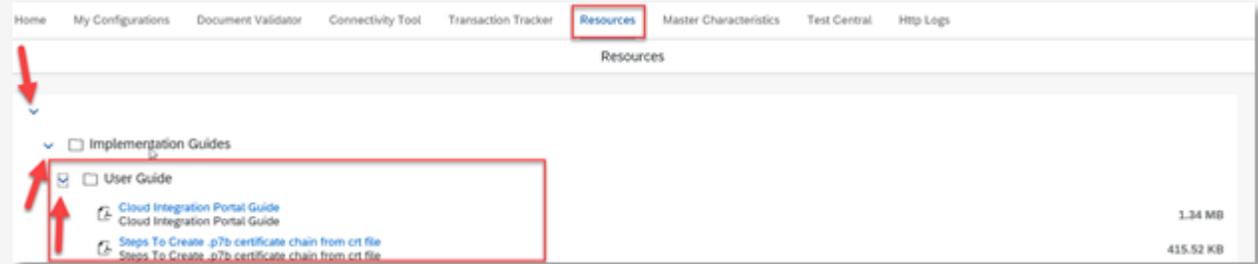

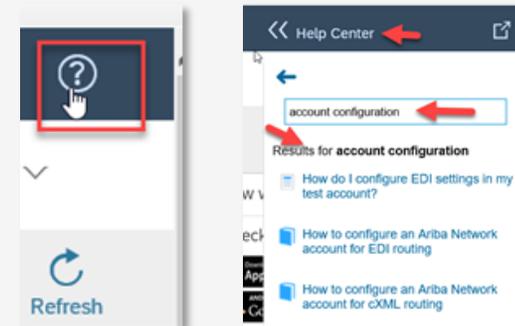
