#### **Feature Description**

The current PDF invoice tiles represent the listing of the invoices converted from PDF files only but with the new Intelligent invoice conversion, these tiles have to be extended to image files that represent scanned paper invoices too.

To make it consistent and keeping the future to support any invoice format, the current tiles will be changed to Invoice conversion tiles

This will be available to both the current PDF uploader partner solution and for the new Intelligent invoice conversion.

### **Prerequisites, Restrictions, Cautions**

#### **Prerequisites**

 Invoices should have been converted using the PDF invoices partner solution or the Intelligent Invoice conversion solution to be listed with these tiles.

#### Restrictions

 In this release, if a supplier who is currently transacting PDF invoices using the PDF Invoicing partner solution, switches to the Intelligent invoice conversion solution and continues transacting, the invoices for both the solutions will be listed under these tiles without any means to identify which solution was used to convert the invoices.

## **User Story**



As a supplier user who uploads their invoices to their SAP Business network account to send to their buyer, <sup>L</sup> they need visibility into the conversion process and see the details of these invoices including the conversion status.

The current workbench offers three tiles for listing the invoices that were uploaded for conversion.

- PDF invoice conversions
- Pending PDF invoice conversions
- Draft PDF invoices for review

Once this feature goes live, the tiles will be consolidated into:


- Invoice conversions (migrated from PDF invoice conversions)
- Draft invoice conversions for review (migrated from Draft PDF invoices for review)

Users who had the previous **Pending PDF invoice conversions** tile will not see this instead can customize the **Invoice conversions** tile with filters to have the same listing of invoices pending conversion functionality.

In addition, the **Invoices** menu will have the existing **PDF Conversions** menu change to **Invoice conversions** to be consistent with the tiles and easily identify the Invoice conversion tiles in the topical invoice workbench.
