Feature Description:

Challenge:

It has been observed that creating quality responses to buyer's leads on SAP Business Network Discovery is time consuming and error prone for the supplier.

Inadequate supplier responses result in rejection of supplier from buyer's and loss of relevant business opportunity. Better RFI responses lead to better conversion rate for suppliers.

Solution:

SAP LLM library OpenAI and Advanced GPT-4 large language model to help suppliers generate better responses for postings.

Process

Supplier chooses to respond to a Discovery Lead

Supplier provides a few prompts/bullet points for their response

Al capability generates response text

Supplier reviews and accepts or adjusts and then submits to buyer **Key Benefits**

With the help of Gen AI response generation, suppliers will be able to:

- Respond to RFIs in a timely manner, even when dealing with complex and detailed requests.
- Using Gen AI for RFI response can help suppliers reduce costs associated with manual labor and resource allocation.
- Gen AI generated RFI response reduces the likelihood of errors or omissions.
- Gen AI generated RFI responses are grammatically correct and consistently written
- Multi language support to help non-English users

Prerequisites

- The users should have "respond to posting on SAP Business Discovery" permission on SAP Business Network
- The functionality will be switched off by default and can only be switched on by Administrator of the account.

Restrictions:

- This functionality is only available for the postings created on New Discovery.
- This functionality is only applicable for private sector RFIs.

Cautions:

- Artificial intelligence can create plausible results, however it can also make incorrect assumptions. Make sure you have reviewed all content generated by AI and adjusted what needed.
- Users should not add their personal information (Personal Identification numbers, social security numbers etc.) for response generation.
- Users should always use polite language in the free text section.

Steps to enable for administrators:


- Go to account settings, the name icon on the right hand top corner.

- Enable it for discovery.


