SS-50641	When would you use Disable Supplier invitation - SS-50641?	Hi, Users can still add suppliers in Sourcing Requests (initial step of the process), but this was not a problem, because this content was not copied to the event. However, later on, we had a new functionality appeared when creating the Sourcing Event, which copies every content from the Sourcing Request, including suppliers (if added in this document). This new functionality might affect some of our user flow so it is necessary to disable "Create Button" in Sourcing Request the same way it was done for the Event.
SS-50729	For SS-50729 - just for clarity, does that mean suppliers can't reply via email to a Ariba sent message or auto message.	They can still reply to the message, just not the email that they receive that message from. When the Reply-to fields is disabled. There will be a message:  - Advises recipients to not reply to the message and that any replies sent will not be deliverable.  - Provides an email address that recipients can send queries and requests to. For example, "For further information, send email to my.name@company.com."  In templates for SAP Ariba Sourcing event notifications, you can use the SPONSOR_EMAIL variable to include the email address of the event owner in the message.

For example, if you want to test something with line items and suppliers, some users might accidently publish it and inviting everyone. With that you don't have to go back and pause/cancel the event, not to mention that you can find out about it too late.
