5: Bank Details

A detailed look below, on how to review Bank Details, the Supplier needs to ensure they attach either a Bank Letter or a Bank Statement from the last 3 months:

- a) Bank Certification Evidence/Attachment showing the Bank Account Name, Sort Code and Account Number, SWIFT code and IBAN Account Number so we can confirm that the bank account does belong to your company. The document should not be older than 3 months.
- b) Swift Code/BIC Code
- c) Bank Key/ABA Routing number this is Sort Code with no hyphens, punctuations, or spaces.
- d) IBAN Number only in those countries where IBAN applies.
- e) Bank Account holder's Name this should be their own bank account, must be only letters, and must follow their Legal Name.
- f) Account Number
- g) Region: please include the Region/County that applies to the bank account address USA has no IBAN. No Bank Key
