Feature Overview

Introducing: Allow to Upload Certificates When Using the Advance Ship Notice Upload File

Feature Description

Customers can now attach Quality certificates during the ship notice upload/download process. This functionality is activated either by a rule or if the purchase order (PO) line item has the certificate flag enabled (even if the rule is off). A new column prompting certificate attachment will be visible to customers.

The rule behavior has been updated; the rule no longer dictates mandatory certificates. Instead, certificates are only mandatory in SAP Business Network if they are flagged as required in the PO line item. This is indicated by the cXML element “CertificateInfo” with the attribute “isRequired=yes”. Certificates without this indicator are considered optional.

Key Benefits

1. Customers can attach Quality certificates during the mass upload process for ship notices.
2. Functionality is activated by PO line-item certificate flag (even if rule is off).
3. Certificates are mandatory only if marked as required in the PO line item (“isRequired=yes”). Otherwise, certificates are optional.
4. If the rule is enabled and the purchase order (PO) line item does not include a certificate indicator, SAP Business Network will present an optional attachment control for suppliers, allowing them to attach a certificate at their discretion.

Updates

1. NEW - The necessity for a quality certificate is now determined only by the flag "certificateInfo Required='Yes'" setting at the PO line-item level.
 - Before, this was managed by flag and rule ON.
2. Rule “Require suppliers to provide a quality certificate on ship notices” now is soft, no longer mandates whether a certificate is required or not required.
 - Name of rule changed to “Allow suppliers to provide a quality certificate on ship notices”
3. New – Attach certificates as optional. If rule is enabled, then application displays an option for customers to attach certificates as optional for all line items.
 - Even if quality info was not sent at PO line item.
